Political Psychology of Global Conflict, Protest and Reconciliation

The theme of the 36th Annual Scientific Meeting of the International Society of Political Psychology was chosen in the wake of the promise and potential wrought by the upheavals surrounding the Arab Spring, the global economic crisis and other changes the world has seen to date. How can protest and violence catalyze change on the world stage? How might processes focused on reconciliation help potentiate enduring prospects for peace and resolution between groups with long history of internecine hatred and dispute? What role does identity politics, religion, ethnicity, or otherwise, play in either precipitating or possibly ameliorating hostility at the individual, community and societal levels? This topic was designed to allow for a full exploration of the political and psychological factors involved in addressing these questions.

The 2013 meeting is being held at The Political Psychology & Decision Making Program (POPDM) of the Lauder School of Government, Diplomacy and Strategy, IDC Herzliya - Herzliya, Israel. We are grateful to the Program Chair, Professor Alex Mintz, Dean of the IDC School, for sponsoring this meeting and to Professor Mintz and his co-chairs, Daphna Canetti and Pazit Ben-Nun Bloom, and their section chairs for putting together such a stimulating group of panels. In keeping with our established theme, the organizers have elicited over 100 papers, posters and roundtable appearances that deal with the Israeli-Palestinian conflict, including 30 that deal directly with peace issues between the Israelis and Arabs. This represents one of the largest concentrations of presentations dealing with the Middle East peace process in our organization's history. In addition, scholars from over 42 different countries have registered to attend the conference, demonstrating the truly increasing international scope of our organization, a goal we strongly hope to enhance in coming years.

In addition, we will once again have the Summer Academy for the third year, following on extremely successful runs in Istanbul and Chicago. We all owe Tereza Capelos a debt of gratitude for her selfless and exceptional service running this institution since its inception.

We hope that everyone in the Society takes the opportunity to read our journal, *Political Psychology*, edited by Alex Mintz. In addition, this coming year will show the rebirth of *Advances in Political Psychology*, under the capable leadership of Howie Lavine.

I would like to express my personal thanks to Sev Bennett, our new Executive Director for her exceptionally hard work professionalizing our Central Office for the

first time in our history. I know that many of you have benefitted from interacting with her over the course of the past year, and more of you will do so over the coming years. She has put in enormous effort to improve and streamline all of our business processes and you should all experience the benefits of these strategies over the coming year, as these improvements in the website, registration and membership processes become more efficient.

I would also like to thank our exceptional Treasurer, Andrea Grove, for her five years of dedicated service to the organization. We are all grateful for her wisdom and careful guidance. The best book award committee, which included Ann Crigler, Elizabeth Theiss-Morse, Peter Suedfeld awarded the Alexander George best book award to Richard Ned Lebow for his book, The Politics and Ethics of Identity and the David Sears book award to Howard Lavine, Chris Johnston and Marco Steenbergen for The Ambivalent Partisan: How Critical Loyalty Promotes Democracy. The Erik Erikson Award for Distinguished Early Career Achievement was given to co-recipients Daphna Canetti and Phillip Hammack; that committee was chaired by Paul Nesbitt- Larking, who will succeed Stanley Feldman as ISPP President. Past ISPP President Bert Klandermans was selected as recipient of the Lasswell award and Past President Kristen Monroe won the Sanford Award; this joint committee was chaired by Daniel Bar-Tal. The Jeanne Knutson award, chaired by Kristen Monroe, was given to Past President Janusz Reykowski. The Roberta Sigel Junior Scholar Paper Award went to Lasse Laustsen and Michael Bang Petersen for "Winning Faces Vary by Ideology: Evolutionary Psychology and the Role of Candidate Facial Traits in Democratic Elections", selected by a committee chaired by Cindy Kam. Please join me in congratulating all our deserving recipients and in thanking all our committee members!

Finally, I hope all of you enjoy the many intellectual and social events planned for this conference, including the Opening Reception, the Awards Reception or the Junior Scholars' Social Hour. I hope each of you has a wonderful time at the conference.

Self-Censorship as a Socio-Political-Psychological Phenomenon: Conception and Research

Daniel Bar-Tal, School of Education, Tel Aviv University, Self-censorship of information, defined as an act of intentionally and voluntarily withholding information from others in the absence of formal obstacles, serves as an obstacle to the proper functioning of a democratic society, because it prevents free access to information, freedom of expression, and flow of information. In societies involved in intractable conflict, this phenomenon is of key importance, as it blocks information that may shed new light on the conflict. In such societies, a variety of potential costs to both the self and the ingroup deter society members from sharing information when such information contradicts the dominant conflict-supporting narrative or presents the group in a negative light. Indeed, self-censorship of information pertaining to the group's relationship with the outgroup is a wide phenomenon in societies involved in intractable intergroup conflict, thus constituting an effective societal mechanism in controlling the flow of information in such societies. The address examines this phenomenon from various angles, both theoretically and empirically, addressing its nature, motivations, relevant factors in its emergence, and wider consequences. It also discusses the process of breaking the silence of self-censorship with its antecedents and consequences.

A Theory of System Justification

John T. Jost, New York University, According to system justification theory, which was first proposed by Jost and Banaji (1994), people are motivated to defend, bolster, and justify aspects of the societal status quo - but not necessarily at a conscious level of awareness. In this talk, Professor Jost will summarize evidence bearing on nine major postulates derived from system justification theory. Topics of special emphasis will include stereotyping, political ideology, and the legitimation of social and economic inequality.

Roberta Sigel Junior Scholar Paper Award

The Sigel Award is given to junior scholar authors of the best papers presented at annual scientific meetings. Nominees must be current ISPP members.

ISPP first announced this award at its Vancouver meeting in 1996. Professor Sigel, whom the award honors, was a distinguished professor of political science at Rutgers University. She was the author and editor of seven books and many articles and book chapters, mostly in the areas of political socialization and democratic citizenship. She had many leadership roles in the American Political Science Association and has served as program chair, Vice-President and President of ISPP.

All ISPP junior scholars who are current dues paid members of ISPP and had their paper accepted for the 2013 summer meeting/conference are eligible to be considered for the award to be presented during the 2014 meeting. Junior scholars are students (graduate or undergraduate) and faculty who received their Ph.D. within the last eight years. Each (of the two) award carries a cash prize of \$250.

There are two prizes with slightly different criteria to accommodate the authorship and publication practices in the various disciplines represented in ISPP:

- The first award is given to the best paper written by junior scholars only. In the case of multiple authors, all co-authors must be junior scholars.
- The second award is conferred to the best paper with a junior scholar first author. This award allows for a senior scholar co-author.

Please nominate (self-nominations are encouraged) eligible papers only (posters are not eligible) and submit them to the email below by **February 17, 2014**. Papers previously submitted to the Sigel Award are not eligible. All submissions will be read by the award committee, consisting of members of the Junior Scholar Committee as well as senior scholars. Two papers will be selected strictly according to scientific excellence and their contribution to research in political psychology.

Best Dissertation Award Announcement 2014

The International Society of Political Psychology is pleased to announce a call for nominations for the Best Dissertation Award, given for the first time at the 2008 Annual Meeting in Paris.

All Ph.D. dissertations within the field of political psychology are eligible for consideration, regardless of home discipline. Dissertations should represent an independent piece of research that is the sole work of the author and gains the highest degree at the author's university.

Nominations are due by **Feb. 17, 2014**, for dissertations completed and successfully defended between Jan. 1, 2013, and Dec. 31, 2013. **Nominees must be current ISPP members.** Nominations should be submitted electronically and must include a one-page abstract (300 word), a 10-page (3,000 word) summary of the dissertation, and a letter of recommendation from the thesis adviser or committee member, all in English.

Ideologies play a major role in politics and have done so for at least the last three hundred years since the term was coined during the French Revolution. Political views on the left and right shed light on some of the major political conflicts of modern times. New ideological perspectives such as green politics, feminism, and religious fundamentalism have broadened the range of political thought and beliefs that shape the character of political discourse. Political psychology was founded, in part, on the desire to understand political ideologies and their adherents and recent research has richly advanced this line of enquiry. This meeting will highlight the important and diverse contributions of political psychology to an understanding of political ideologies and their effect on politics and conflict in a global context.

We welcome individual papers and posters, as well entire panels and roundtables, which present theory and research on political ideologies and belief systems. In addition to research on traditional lines of ideological conflict, we encourage submissions on newer and emerging belief systems across the world. Research can draw on all of the theoretical perspectives and methods in the field of political psychology including, but not limited to, social communications, personality, leadership, values, cognitive and motivational processes, intergroup relations, collective action, and genetic and biological factors. We are particularly interested in proposals that provide new theoretical or empirical insights into the foundations of ideologies as well as research that examines conditions under which ideologies lead to political conflict and when they can help foster cooperation.

We also welcome panels, papers, posters, and roundtables on any topic in political psychology. The program chairs are interested in bringing together new research from the fields of psychology, political science, sociology, anthropology, biology, communications, economics, and philosophy.
